- 2. Type of purchaser: Business company
- 3. Type of public procurement procedure: Open procedure
- 4. Description of the subject of the public procurement: VJN 02/20 Works on the construction of two free-standing multifamily residential buildings: Building 6 on the cadastral lot 4412/41 and Building 7 on the cadastral lot 4412/42 with landscaping around buildings and corresponding landscaping within blocks on the part of the cadastral lot 4412/54 Cadastral Municipality Kragujevac IV, City of Kragujevac,

- 5. The criterion for contract award: The criterion for the award of a contract under this public procurement is the lowest price offered.

- 7. A way of submitting the offer: The whole offer has to be prepared in compliance with this Invitation and Tender documentation for the public procurement. It is necessary to indicate on the back of the envelope the business name and address of the tenderer.
- 8. The deadline for submission of offers is 31st of March 2020, until 09:30 a.m.



- **9.** Place, time and way of opening of offers: The opening of offers is on 31st of March 2020 at 10:00 a.m. in the premises of the Building Directorate of Serbia Llc in Belgrade, 110 Bulevar Arsenija Carnojevica Street, Belgrade-New Belgrade. The opening procedure shall be public and shall be done according to the time of the receipt of offers from the earliest to the latest offer received.
- 10. Conditions under which the tenderers' representatives may participate in the offers opening procedure: The offers opening procedure will be open for attendance of authorized tenderers' representatives who are required to prove their status of the tenderers' representatives by submitting the authorization which is signed and certified by the authorized person of the tenderer to the Committee for public procurement or public procurement officer, immediately before the opening of offers.
- **11. The deadline for making a decision on awarding the contract:** The deadline for making a decision on awarding the contract is up to fifteen days from the day of opening of offers.
